Adjusted to reflect a 2-for-1 stock split effective February 14, 2003.
- Includes 51 shares acquired on March 7, 2003 under the Microsoft dividend reinvestment plan and 930 shares acquired on June 30, 2003 under the employee stock purchase plan.
- This total represents shares owned as of June 30, 2003.
- Adjusted to reflect a 2-for-1 stock split effective February 14, 2003.
- The option vests over 5 years at the rate of 12.5% on January 31, 2004 and then at the rate of 12.5% each six months thereafter.
